Greenways Mini-Grants Awarded



Through \$125,000 of funding available by the Department of Conservation and Natural Resources (DCNR) Community Conservation Partnership Grant Program (C2P2), Round 5 of the Southern Alleghenies Planning & Development Commission's (SAP&DC's) Southern Alleghenies Regional Greenways Mini-Grants Program has awarded funding to the following 5 projects totaling \$124,851:

- Fort Fetter Community Design Project Township of Blair
- Reservoir Park Basketball Court Renovation Tyrone Sports Association
- PA Avenue Pedestrian Walkway Mount Union Borough
- Somerset Lake Nature Park Trail Development Project Somerset County
- Stonerstown Recreational Park Improvement Project Liberty Township

This round, we received a total of eight applications and were able to fund five of the eight. We encourage any non-profit or municipality to apply to the program, which opens every spring around April. You can read the guidelines for the program at the link below.

Broadband Taskforce Update

Southern Alleghenies Regional Broadband Taskforce:



SAP&DC submitted a \$50,000 grant application to the Appalachian Regional Commission (ARC) on April 10, 2019, with \$50,000 local match from eight participating counties, to complete a Broadband Feasibility Study. In late July 2019, ARC awarded the \$50,000 grant to complete the study. The counties to be covered are Bedford, Blair, Cambria, Fayette, Fulton, Huntingdon, Somerset, and Westmoreland.

The next step the Regional Broadband Task Force will take is to develop a Request for Proposal (RFP) for individuals or businesses to submit proposals for the eight-county Broadband Feasibility Study. The feasibility study will address:

- 1. Unserved and underserved areas;
- 2. Level of service being provided, the needs of local businesses and the reliability of the current services being provided;
- 3. Provide an inventory of broadband assets already in place;
- 4. Assess community broadband requirements for bandwidth needs;
- 5. Determine best technologies to meet the coal impacted community needs; and
- 6. Provide cost estimates for different deployment strategies.

The RFP will be out for bid in October 2019 with hopes for a final completion of the study in approximately eight months timeframe.

Appalachian Regional Commission

In July 2019, SAP&DC was notified of two 2019 grant application awards: the Center for Metal Arts (CMA) in Johnstown and Saint Francis University (SFU) in Loretto.

CMA was awarded \$21,430 for their program of a community of metalsmiths, entrepreneurs and students exploring new skills or mastering advanced techniques in the metal arts through an array of workshops. Upgrades will be made to the CMA facility located in the historic Lower Works of the Cambria Iron Company in downtown Johnstown. These upgrades are needed to provide students the most up to date, quality learning experience



during their time at CMA. Additional lighting, tongs, hammers and additional forging tools will be added. A total of 270 students will be served and 8 additional jobs will be created.

SFU was awarded \$150,000 for the new Health Sciences Experiential Learning Commons. The equipment will be used by healthcare students and professionals to develop their clinical decision-making abilities and improve their confidence to manage similar real-life situations in a safe, non-threatening environment. The equipment purchased will include new simulators and simulation-related equipment such as cameras, microphones, and cables to compliment the new facility. A total of 900 students will be served through advanced simulation training and 250 EMS/emergency responders will be served through the new equipment.

On August 2, 2019, SAP&DC submitted the FY 2020 Investment Package to ARC with a total of four projects for our six-county region totaling \$2,030,375.00. The projects ranged from water system upgrades and planning grants to roadway projects. SAP&DC staff will meet with ARC in September regarding the projects and final decisions will be made by December 2019 for funding.
