### Real ID Deadline Postponed Due to Coronavirus by Andrea Noble, Staff Correspondent, Route Fifty

Americans will have more time to obtain driver's licenses that comply with stricter standards outlined in the federal government's Real ID law.

President Trump announced Monday that he is pushing back the Oct. 1 deadline that would have required Americans to have either a Real ID compliant license or

passport in order to board a domestic flight.

The decision comes as state governments are preoccupied with the coronavirus outbreak and many motor vehicle departments have closed. Americans also have been warned to avoid crowds to prevent the spread of the virus.

"We are postponing the deadline for compliance with Real ID requirements at a time when we are asking Americans to maintain social distancing," Trump said at Monday's White House press conference.

No new deadline for compliance has been set, though Trump said a new date would be announced soon.

**GSA Grants 60-Day Extension of Expiring Entity Registrations in SAM.gov  
by the U.S General Services Administration (GSA)**

In support of the U.S. government's response to the COVID-19 national emergency, the Office of Management and Budget (OMB) requested certain administrative relief for entities doing business with the government. As part of that effort, GSA has initiated 60-day extensions to SAM.gov registrations that have expiration dates ranging between March 19, 2020 and May 17, 2020. It will take GSA until March 28, 2020 to complete all extensions. This effort is intended as relief for those otherwise required to re-register during that time frame.

There is no action required on the part of registrants; this notice is for awareness only.

As an example, an entity that is set to expire on April 1, 2020 will be automatically granted an extension to May 31, 2020.

There are a total of 61,298 registrations that will be impacted by this extension. We will process the extensions in a deliberate, incremental manner throughout the course of a week to lessen the impact on our interfacing systems.

As part of this effort, entity administrators impacted by this change will receive an email with the subject line

"60-Day SAM.gov Extension Granted for [Entity Name/DUNS/CAGE]."

The new expiration dates will be included in the SAM entity management extracts and available through web services after the records are extended. Interfacing systems need only consume the data as normal.

The Commonwealth of Pennsylvania, Department of General Services release the new Small Business (SB), Small Diverse Business (SDB), and Veteran Business Enterprise (VBE) management software, PRiSM, on September 3, 2019. The software can be accessed at [please visit](#)

PRiSM supports the mission of the Department's Bureau of Diversity, Inclusion & Small Business Opportunities (BDISBO) to assist small, diverse, and veteran businesses in competing for Commonwealth contracting opportunities. The Software allows:

- Prime vendors to report payments to their SDB and VBE vendors
- SDB and VBE vendors to acknowledge receipt of Prime payments
- BDISBO to track payment compliance

The PRiSM is meant to replace the PA SBPI certification, and be used as a portal to identify your firm as a Disadvantaged Business Enterprise (Woman-, Minority-, and/or Veteran-owned; DBE). You will still need to register your company to do business with the Commonwealth in the PA Supplier Portal.
