

# DCED GREENWAYS, TRAILS, AND RECREATION PROGRAM FUNDING



The Department of Community and Economic Development (DCED) Greenways, Trails, and Recreation Program (GRTP) is still open for applications until May 28, 2021. Also known as

Act 13 of 2012, the program establishes the Marcellus Legacy Fund and allocates funds to the Commonwealth Financing Authority (the "Authority") for planning, acquisition, development, rehabilitation and repair of greenways, recreational trails, open space, parks, and beautification projects using GTRP.

Eligible projects involve development, rehabilitation, and improvements to public parks, recreation areas, greenways, trail, and river conservation. Grant requests to the program cannot exceed \$250,000 for any project. A 15% match of the total project cost is required.

### Eligible entities include:

- For-Profit Businesses
- Municipalities
- Councils of Governments
- · Authorized Organizations
- · Institutions of Higher Education
- · Watershed Organizations

## DCED MULTIMODAL PROGRAM OPENS



The DCED Multimodal Transportation Fund (MTF) provides grants to encourage economic development and ensure that a safe and reliable system of transportation

is available to the residents of the commonwealth.

Applications for the MTF will be accepted between **April 22**, **2021**, **and July 31**, **2021**. All applications and all required supplemental information must be electronically submitted by close of business on July 31, 2021, for hopeful consideration at the November CFA board meeting. Please note that technical assistance will not be available after 5pm on July 30, 2021.

Funds may be used for the development, rehabilitation, and enhancement of transportation assets to existing communities, streetscape, lighting, sidewalk enhancement, pedestrian safety, connectivity of transportation assets and transit-oriented development. Eligible entities are the following:

- Municipalities
- · Councils of Governments
- Businesses
- Economic Development Organizations
- Public Transportation Agencies
- · Ports-Rail/Freight

MTF grants are available for projects with a total cost of \$100,000 or more. Grants will not exceed \$3,000,000 for any project

## **EXECUTIVE ORDER 12372 PROCESS**

SAP&DC is the SPOC (Single Point of Contact) for the Intergovernmental Review Process (required by **Executive Order 12372**) for the six-county region, which structures the federal government's system of consultation with state and local governments on its decisions involving grants, other forms of financial assistance, and direct development.



Executive Order (EO) 12372 establishes the framework for SAP&DC to review consistency of the projects with the region's 2020-2024 Comprehensive Economic Development Strategy (CEDS) Plan (<u>located here</u>). Examples of grants that may require an EO are PENNVEST, USDA, EDA, EPA, etc.

Requests for project reviews can be submitted by completing the EO 12372 Review Request Form (<u>submit form</u>). The Commission's Board of Directors provides their final recommendations to the respective funding agencies. SAP&DC staff responds to all EO 12372 inquiries within 60 days.

# Local Technical Assistance Program (LTAP) DROP-IN COURSES AND VIRTUAL TRAININGS

#### **Drop-in Session Information:**

LTAP Virtual Drop-ins are centered on various safety and maintenance topics. These sessions are **not** virtual classes; they are informal one-hour live sessions focused on networking and sharing information with other municipal roadway personnel. Whether you're new to the virtual world or have lots of experience, you will enjoy meeting up online with LTAP staff and other municipal staff to learn and discuss information critical to your job. LTAP staff will start the session with a short presentation and then open the discussion to attendees to ask questions and share their experiences. LTAP will guide the discussion to keep it focused and accurate.

Technical assistance topics can include (but are not limited to):

- Speed/Traffic Calming
- Traffic Studies
- Pavement Management
- Winter Management (including snow plow driver training)
- Posting and Bonding
- Bridge and Culvert Management
