## ECONOMIC DEVELOPMENT ADMINISTRATION AMERICAN RESCUE ACT PLAN FUNDING



Under the American Rescue Plan, EDA was allocated \$3 billion in supplemental funding to assist communities nationwide in their efforts to "build back better" by accelerating the economic recovery from the coronavirus

pandemic and building local economies that will be resilient to future economic shocks.

American Rescue Plan funding enables EDA to provide larger, more transformational investments across the nation, while utilizing its greatest strengths, including flexible funding to support community-led economic development.

With an emphasis on equity, EDA investments made under the American Rescue Plan will directly benefit previously underserved communities impacted by COVID-19.

EDA is making a Coal Communities Commitment, allocating \$300 million of its \$3 billion American Rescue Plan appropriation to ensure support for these communities as they recover from the pandemic and create new jobs and opportunities, including through the creation or expansion of a new industry sector. This commitment will be fulfilled through \$100 million in Build Back Better Regional Challenge grants and \$200 million in Economic Adjustment Assistance grants.

Deadlines vary based on each program. The following are the various programs and their deadlines:

- Economic Adjustment Assistance March 31, 2022
- Travel, Tourism and Outdoor Recreation January 31, 2022
- Indigenous Communities September 30, 2022
- Build Back Better Regional Challenge (Phase 1) October 19, 2021
- Statewide Planning, Research and Networks October 31, 2021
- Good Jobs Challenge January 26, 2022

## ABANDONED MINE RECLAMATION (AML) PROGRAM

The Bureau of Abandoned Mine Reclamation (BAMR) under the Department of Environmental Protection (DEP), administers and oversees the Abandoned Mine Reclamation Program in Pennsylvania and the Abandoned Mine Land Economic Revitalization (AMLER) funds. The bureau is responsible for resolving abandoned mine land



(AML) problems such as mine fires, mine subsidence, dangerous highwalls, open shafts and portals, mining impacted water supplies and other hazards which have resulted from past coal mining practices in accordance with requirements established by the federal Office of Surface Mining (OSM) under authority of the Surface Mining Control and Reclamation Act (SMCRA) (PL 95-87, as amended).

SMCRA defines three priorities and establishes that expenditures of moneys from the fund shall reflect the following priorities in the order stated:

- Priority 1 (P1) the protection of public health, safety, and property from extreme danger of adverse effects of coal mining practices.
- Priority 2 (P2) the protection of public health and safety from adverse effects of coal mining practices
- Priority 3 (P3) the restoration of land and water resources and the environment previously degraded by adverse effects of coal mining practices including measures for the conservation and development of soil, water (excluding channelization), woodland, fish and wildlife, recreation resources and agricultural productivity.

Two categories of projects are accepted through the program:

- 1. "Category A" Projects (Reclamation with Development)
- 2. "Category B" Projects (Reclamation for Potential Development)

When PADEP-BAMR performs any work, it must prove the P-2 site was not mined for profit after 8/3/1977. The 8/3/1977 federal OSMRE eligibility date only applies to work being performed by PADEP-BAMR funded by OSMRE. BAMR is permitted to utilize P3 spoil piles to backfill P1 and P2 dangerous highwalls.

### STEM TALENT CHALLENGE



The U.S. Economic Development Administration (EDA)

launched the STEM Talent Challenge to support programs to train science, technology, engineering, and math (STEM) talent and fuel regional innovation economies across the nation.

The \$2 million <u>STEM Talent Challenge</u> will provide funding for work-and-learn programs to

increase America's STEM-capable workforce in emerging and transformative sectors such as space commerce, aeronautics, digital manufacturing, biotechnology, advanced manufacturing and cybersecurity.

Competition applicants may request up to \$250,000 for implementation of a 24-month workforce program that complements their region's innovation economy. The deadline to apply is Oct. 12, 2021.
