GSA's DUNS Replacement Set to Go Live

[A note from GSA with the schedules of downtimes for the various systems that SAM touches.]

All entities need a unique identifier for federal awards purposes. On April 4, 2022, that identifier is changing from the DUNS Number to the Unique Entity ID (SAM), issued by SAM.gov.

All IAE Systems (SAM.gov, eSRS, FSRS, FPDS, FAPIIS, and CPARS) will be down for

maintenance to complete the transition to the new identifier ahead of April 4, 2022.

Save all work before system downtimes to ensure it will be available again when the systems are back online. The General Services Administration is ready to flip the switch in early April on the non-proprietary entity identifier that is replacing the old DUNS number in federal contracting systems.

The General Services Administration wants all organizations that conduct business with the federal government to take steps to prepare for the switch to the new identification system that is replacing the proprietary DUNS number.

On April 4, GSA is switching to the new "unique entity identifier"—a nonproprietary system—for federal contracting purposes. The move is the culmination of a long-planned transition away from the DUNS Number, which was codified into the Federal Acquisition Regulation in 1998 and has since served as the primary entity identifier for all GSA systems users. The Labor Department is taking on the "most comprehensive review" of a contractor construction wage law in 40 years, which would align with the Biden administration's other priorities.

The department announced on Friday a proposed rule to update the Davis-Bacon and Related Acts, which require contractors and subcontractors that work on federally funded or assisted contracts over \$2,000 for construction, alterations, or repairs for public buildings or public works to pay their workers at least the locally prevailing wage and fringe benefits for similar work in the area.

"Federal dollars should be used to create good jobs in local communities all across our country," Labor Secretary Marty Walsh said in a statement. "These proposed regulations are good for workers, good for building high-quality infrastructure and for ensuring we have a strong construction industry, as we rebuild America."
