Each mission participant will receive a customized schedule of B2B meetings with prospective customers and business partners. Mission participants will also benefit from networking events and logistical support provided by the GSGP India Trade Office.

Why India?

There was significant US export growth in 2022, up 18%. Great Lakes states saw a greater increase at 26%.

Costs

Participation Fee: US\$1,750 per person US\$750 for each additional participant Top export sectors include aviation and defense, education, environmental technology, energy, healthcare and medical equipment, information technology, chemicals, food and agriculture, safety and security, and travel and tourism.

India has a very large domestic market (population of 1.4 billion), with more than half of the population younger than 25 years old. There is an emerging middle class with the ability to purchase US goods and services.

India's GDP grew 7.3% in 2022, and is forecast to grow 6% in both 2023 and 2024.

India is a face-to-face society, and in-person meetings are typically necessary before formalizing business partnerships. Market Research & Customized Appointment Setting Fee: US\$5,500

WHY VIETNAM AND THE PHILIPPINES?

Costs

Vietnam has the fastest growing middle and affluent class in the region, increasing trade with the US and neighbors in Asia.

With increasing urbanization, a growing middle class, and a large and young population, the Philippines' economy shows strong consumer demand and a vibrant labor market.

Top export sectors include agriculture, aviation, defense and security, education and training, healthcare, information technology, power generation, transmission and distribution, and environmental technology.

Strong GDP growth of 8% in Vietnam and 7.4% in the Philippines was achieved in 2022, with forecasted growth of 6% in each country in 2023 and 2024.
