BIS offers Best Practices: Certification to Prevent Diversion to Russia

BIS, together with allies and partner countries, has identified [forty-five Harmonized System \(HS\) codes](#) covering controlled items at heightened risk of being diverted illegally to Russia because of their

importance to Russia's war efforts.

Given the heightened threat resulting from Russia's continued attempts to evade U.S. export controls through third countries for which a BIS export license is generally not required, it is recommended that, at least for transactions involving these nine Highest Priority Items with parties in countries outside of the Global Export Controls Coalition (GECC), exporters seek assurances of compliance with U.S. Export controls. It is a best practice to receive these assurances in writing, for example, through a signed certification statement.

High Priority Items List

HS Code HS Description and Representative Part

- 8542.31 Electronic integrated circuits: Processors and controllers, such as microcontrollers
- 8542.32 Electronic integrated circuits: Memories, such as SRAM
- 8542.33 Electronic integrated circuits: Amplifiers, such as op amps
- 8542.39 Electronic integrated circuits: Other, such as FPGAs
- 8517.62 Machines for the reception, conversion and transmission or regeneration of voice, images, or other data, such as wireless transceiver modules
- 8526.91 Radio navigational aid apparatus, such as GNSS modules
- 8532.21 Tantalum capacitors
- 8532.24 Multilayer ceramic capacitors
- 8548.00 Electrical parts of machinery or apparatus, not specified or included elsewhere, such as EMI Filters

BIS has identified information and assurances that can help prevent the diversion of Highest Priority Items to Russia through non-GECC countries.
