### **Pentagon Issues Proposed CMMC Rule**

The long-anticipated draft rule, which will be officially published on Dec. 26, outlines proposed updates to DOD's cybersecurity requirements for defense contractors and subcontractors who handle sensitive military data. [Editor's note: Comments will be received through 26 FEB 2024.]

The Pentagon is poised to release its draft updates to cybersecurity requirements for defense contractors and subcontractors next week, with the proposed rule seeking to tighten up current cyber requirements for firms that handle sensitive military

information.

The proposed updates to the Department of Defense's Cybersecurity Maturity Model Certification — or CMMC — program are set to be officially published in the Federal Register on Dec. 26. CMMC, which went into effect in 2020 and was updated in 2021 to streamline some of its requirements, outlines baseline security standards for the over 70,000 companies that do business with DOD.

### **GSA Launches Text Message Service for Government Programs in Four Localities and States**

The General Services Administration's pilot to send customized text reminders to individuals at critical moments during the enrollment and renewal of federal benefit programs — such as upcoming application deadlines — has onboarded two states and two distinct cities and counties, GSA announced Thursday. State and local governments can also use the service to send messages to their own staff, GSA says.

Norfolk, Virginia and Montgomery County, Maryland, as well as the states of Wisconsin and Washington, will use the pilot — called Notify.gov — to send messages about federal programs administered on the local level, according to a GSA spokesperson.

GSA had been working with Norfolk's Department of Human Services already as its first partner on a texting campaign around changes to eligibility rules for federal programs at the end of the public health emergency for the coronavirus pandemic, specifically about recertifying for Medicaid, according to performance.gov. ### **IRS Direct File Participants Will Have to Use ID.me for Identity Verification**

The IRS still isn't ready to field the government-provided Login.gov for digital access to taxpayer services.

The coming IRS direct file pilot, which will allow taxpayers in certain states to file their taxes directly to the government, will require participants to verify their identity via ID.me, according to a new IRS blog post.

That means that the IRS still isn't ready to adopt the government-owned identity solution Login.gov. IRS officials have had concerns about the security features of Login.gov, which has been in hot water this year over the fact that it doesn't meet certain identity verification standards. Since then, the General Services Administration announced that it will be adding face matching technology to Login.gov to meet the standard in question.

But sticking with ID.me could resurface old controversies. The vendor came under scrutiny from lawmakers and civil society groups in early 2022 after the IRS started using ID.me — which offers facial recognition to verify identities — to its sign-in processes for online IRS accounts.
