She was introduced to the **HUBZone Socio-Economic Certification** and like the benefits it encompassed. Due to this, she decided to pursue the certification. The application was submitted in late August, after Helen gathered all the necessary documentation that was needed for the application. On October 20, 2023, the HUBZone certification was awarded to her. She is now able to pursue set-a-side HUBZone certification solicitations for federal government contracting. Helen was also able to generate a position at her company. She hired an accounting assistant/special project coordinator. Work has not stopped. She continued working on her capability statement, cybersecurity compliance and possibly pursuing woman owned small business certification.

The APEX has assisted the client from how to get started pre-application, reviewed documents needed to apply for certification and application. This is the first VOSB/SDVOSB certification both applied for and successfully received in the region in over two years.

Ms. Watts, owner, contacted the APEX Accelerator staff to help with submission of paperwork for a solicitation that was released at the end of October. Staff had met with Ms. Watts and assisted with bid preparation paperwork. During this time, staff had noticed that one of the required documents was not included in the documentation the "site visit document" was missing. Staff had contacted the point of contact (POC) on the bid and had them email it to us. Ms. Watts was able to get a site visit appointment with the Attorney General Criminal Law office in State College for that afternoon. After the paperwork was completed, we were able to login to the PA Supplier Portal to upload the documents and answer the questions for the bid submission. Internet service in Bedford County is very spotty; Ms. Watts prefers

any bid submission to be uploaded through the APEX Accelerators office. Ms. Watts was awarded the contract in November.
