Harmonized Tariff Schedule - 2025 Changes

Have you been keeping track of all of the changes to the Harmonized System throughout the year? If you haven't, take the time and review your HS numbers to ensure there haven't been any changes. There were about ten pages of changes throughout 2024. So along the lines of new year - fresh start, now is the perfect time to review your HS numbers to ensure nothing has changed and you won't have hiccups later on!

When Can You Throw Away Your Export Documents?

Most export regulations require you to keep copies of your export documents for a minimum of five years, but recent changes have bumped that requirement to 10 years in some situations. Learn how the updated rules affect document retention timelines, when the retention period starts and which export documents you must save.

Although it may seem like a headache to keep all your paperwork, there are quite a few rules regarding export document retention. If you do toss your export paperwork without paying attention to those rules, you could be in for an even bigger headache.
