Jennifer Judd, of Jennifer Judd Designs, LLC. an SDVBE Graphic Design business based in Bedford County is part of a proposal by prime contractor DMA for the

upcoming fiscal year. They'll work with the collective of providers called the Western PA Continuum of Care (CoC) to continue support for working with the homeless and housing providers. A significant focus of next year's work includes the development of 501c3 organization as well as increasing engagement with the larger community around the issue of homelessness. The goal is to increase volunteerism, engage landlords and employers, and engage specific target groups. Adding an artist & graphic designer to the team was a way to add skills to this outreach and communication effort. Jen's experience with designing, for social issues as well as volunteering for community non-profits also added value to the proposal. Whether they get the contract is yet to be determined, but this is a great example of how a VBE could be used to add value to a proposal...in a way that's outside the box.
